Subject: Exemption of White Category Industries from Requirement of Consent to Establish and Consent to Operate

Reference:

- GPCB Office Order No. P-1/14(6)/675900 dated 22/06/2022
- Resolution passed in the 279th Board Meeting dated 15/05/2025
- GPCB Office Order No. GPCB/P-1/14(8)/09 dated 05/06/2025

The Gujarat Pollution Control Board (GPCB) had earlier exempted certain cottage and small-scale industries with no pollution potential from obtaining Consent to Establish and Consent to Operate. Following CPCB's harmonized classification of industries into Red, Orange, Green, White, and Blue categories, and in line with the directions issued under Section 18(1)(b) of the Water and Air Acts, GPCB has now adopted the revised framework.

As per this classification, White Category industries—having Pollution Index (PI) less than 25 and no pollution potential—are henceforth exempted from obtaining Consent to Establish and Consent to Operate from GPCB.

These industries shall, however, **intimate the Board** about their operations and **self-declared compliance** with environmental laws, in accordance with the Standard Operating Procedure (SOP) prescribed under the MoEFCC notification referenced above.
